- All major works on stand design and exhibit arrangement should be completed by 16:00. It is allowed to stay at the stands and carry out minor design work until 19:00.
- All representatives of the Exhibitor and developers engaged by the Exhibitor must leave the exhibition hall no later than 19:00 / 16:00 Moscow time. The Exhibitor shall be responsible for the actions of attracted third parties. For the Exhibitor's or its builder's failure to vacate the halls on the days of installation, exhibition operation, as well as dicmantling, the Exhibitor shall be obliged to reimburse the Organizer for the losses actually incurred and documented related to this.
- All Exhibitor's materials and structures must be removed; otherwise, further responsibility for their safety (or complete disposal of disposable structures) shall be borne by the exhibiting company.
- All construction materials, structures and bulky waste shall be removed from the territory of the exhibition center at the expense of the Exhibitor or its developer. If necessary, Developers / Exhibitors shall order in advance the disposal of garbage into containers.







1. GENERAL INFORMATION

submitting the Application for participation in the Event, the Exhibitor assures EXPO FUSION LLC that he/she is familiarized with the following documents: - "Basic Requirements for Holding Events at Crocus Expo IEC", including Annexes thereto, including Annex 2 "Penalties for Violation of the Basic Requirements for Holding Events at Crocus Expo IEC" posted on the website at http://www.crocus-expo.ru, in the part established for developers, exhibitors and participants; - "Basic Requirements of the General Developer BuildExpo LLC, when arranging exhibition events at Crocus Expo IEC", including Appendices to them, posted on the website at: https://www. buildexpo.ru, in the part established for developers, exhibitors and participants, the Exhibitor undertakes to comply with the rules of the documents (Requirements) specified in this clause during the term of the Contract with ExpoFusion LLC.

1.1. STAND INSTALLATION AND CARGO DELIVERY

Stand installation can be started on the first day of set-up and must be finished not later than 16:00 hours of the last day of set-up. Cargoes not unpacked by 16:00 hours of the last day of set-up will be removed and stored at the exhibitor's expense. They can be returned not earlier than 18:00 hours of the first day of the exhibition.

1.2. TECHNICAL SPECIFICATIONS OF PAVILIONS

For configuration, dimensions and existing building restrictions, heights under balconies and transitions, location and dimensions of assembly gates and inter-area doors, freight elevator dimensions, and manhole locations, see the website at http://www.crocus-expo. ru, under "Official Documents"

1.3. Electricity, water and compressed air

a) Electricity

Voltage of lighting network: 220V.

Voltage of power network: 3-phase alternating current 380V with limited load on neutral conductor.

All power connections shall be made with the cable provided by the exhibitor.

Frequency of current in the power network - 50 Hz. Electric motors with a power of over 20 kW must be switched on through a starting protection device with a limiter.

For the purpose of reliability and safety of operation, electricity supply from the main switchboard and connection to the stand must be carried out only by EXPO FUSION LLC. The application for these works shall be made on special forms.

The electrical installation within the stand is carried out by EXPO FUSION LLC. on the basis of an order. Within the stand, electrical installation can also be carried out by electricians of the exhibitors themselves or third-party companies, who have special authorizations to carry out such works in accordance with the requirements and level of technology, and who have the appropriate electrical safety qualification (not lower than group 3 according to Russian standards). All electrical installation work must be carried out in compliance with the applicable Electrical Installation Operating Rules (EER), Safety Regulations (SR), Electrical Installation Rules (EIR), Fire Safety Rules in the Russian Federation and Construction Norms and Regulations (SNiP). At the same time it is necessary to fulfill special requirements due to the peculiarities of exhibition events. All electrical installations and units must also comply with the requirements in force in the Russian Federation. The electrical wiring at the stand may be used during the exhibition only if authorized by EXPO FUSION LLC. At the time of acceptance of the stand, certificates confirming that the stand has been inspected must be available.

b) Water

Necessary installation work for reasons of operational safety may only be carried out by EXPO FUSION LLC. Work orders must be submitted on the appropriate forms.

c) Compressed air

The compressed air supply to the stands (max. 7 bar) is provided from the installations of EXPO FUSION LLC. A proper filter must be provided on the exhibitor's side. The installation and use of own compressors is not permitted.

Exceptions are possible on the basis of a separate request. The noise level at the stand boundary must not exceed 75 dB (A).

Please note that the stand layout may not always be optimized due to the presence of columns, switchboards, compressed air, water and drainage systems, fire hydrants, etc. Please note that cables and hoses may need to be laid openly (visible).

In the event of a power failure, you must inform the exhibition management immediately. The organizer of the exhibition will not be liable for any lossesand damages resulting from power outages.

! FORBIDDEN!

Attachment of the Exhibitor's equipment to the stand structures, gluing foreign objects to the elements of structures, making holes, attaching advertising and other materials with pins, buttons, etc., without written approval from the General Builder







1.4. MOVING EXHIBITS AROUND THE EXHIBITION AREA, EXHIBITING AND DICMANTLING EXHIBITS

The transport of exhibits to and from the stand, the storage of empty containers, the use of lifting and transport vehicles, the use of personnel for packing and unpacking of exhibits, their installation and dicmantling, packing at the end of the exhibition and other related activities are exclusively the business of the exhibitor.

Transportation and forwarding services at the exhibition complex are handled exclusively by the forwarding company. Any liability of EXPO FUSION LLC in this respect is excluded.

1.5. CUSTOMS FORMALITIES

All necessary customs formalities for exhibits and stand materials must be complied with by the exhibitor himself. The exhibitor will be informed of any additional details required regarding the movement of exhibits, including representative goods and printed material, by the forwarding agent in the form of a circular letter.

2. STAND INSTALLATION AND EQUIPMENT

2.1. Stand equipment, design, advertising and personnel

For exhibitors carrying out construction on their own independently:

Verification and coordination of technical documentation for independent builders, control of technical documentation of power grids for independent builders, control of audio-video equipment used at the exhibition events, services for static calculations, electrical laboratory, fire safety services, rental of winches are subject to coordination in BildExpo LLC, Technical Documentation Control Department: + 7 (495) 727-26-71.

For exhibitors carrying out construction on their own through **Expo Fusion LLC:**

For standard stand construction, the Exhibitor shall order an equipped area with a standard set of equipment from EXPO FUSION LLC (specified in the Application for Participation). Additional equipment may be ordered from EXPO FUSION LLC in due time before the start of installation. The installation shall be carried out by the General Developer within the allotted timeframe. At the same time, the Exhibitor assumes material responsibility for the rented stand equipment. In case of loss of the property rented from EXPO FUSION LLC, the Exhibitor shall pay to EXPO FUSION LLC the cost of the lost property (without discount), in case of damage, the Exhibitor shall compensate the cost of the damage. The Exhibitor shall coordinate the stand layout with EXPO FUSION LLC in due time and in the prescribed form. Otherwise, EXPO FUSION LLC shall place a standard set of equipment on the stand and place the Exhibitor's name on the frieze at the Exhibitor's expense on the basis of the Exhibitor's data available to EXPO FUSION LLC.

! The equipment owned by the Exhibitor, which he wants to bring to his stand (hangers, furniture, audio-video equipment, decor elements, etc.) should be coordinated with BildExpo LLC, +7 (495) 727-26-71.

Locks with keys for doors, showcases, etc. are issued by the General Developer against deposit on the day of arrival.

Ordering of additional equipment during installation shall be done through the General Builder at special rates and if the General Builder is able to fulfill the order.

Wall panels and other structural elements shall be handed over after the Event undamaged and cleaned of tape residue, etc.

It is prohibited to attach the Exhibitor's equipment to the stand structures, glue foreign objects to the structural elements, make holes, attach advertising and other materials with pins, buttons, etc., without written approval of the General Developer.

On the days of installation or the days of the Event, the stands mounted/designed by the General Builder shall not be subject to any independent (not coordinated with EXPO FUSION LLC) changes, full or partial dicmantling works by the Exhibitor and its contractors.

In case of violation of this condition, the Exhibitor shall be fined according to a tripartite Act signed by the Exhibitor, EXPO FUSION LLC and the General Developer.

Foundations, anchor holes (drilling holes) and laying cables in the floor are not allowed. The use of the rear part of the walls of other stands is prohibited.

Each exhibitor/stand builder is obliged to install the required number of his own walls. The floor of each rented stand must be carpeted or otherwise covered.

The dicmantling of the stand may be carried out within the time allotted for this purpose. Exhibitors must clean their stands before 19:00 on the last day of the exhibition and hand them over to the organizer in the condition in which they received them. Possible damage to the walls, floor, ceiling, etc. will be repaired at the exhibitor's expense.

During the exhibition, sufficient personnel must be present at the stand to provide information.







2.2. CONSTRUCTION HEIGHT

Construction heightThe permitted construction height the exhibition is 4 m

The permitted height of the suspended structure is 5 m

The standard construction height for all stands is 2.50 m. An increase in height against the specified height is only possible with the permission of EXPO FUSION LLC This condition also applies to suspended structures suspended from the ceiling of the pavilion. If the height exceeds 2.50 m, a distance of 1 meter must be maintained to the neighboring stand.

These restrictions do not apply to exhibits.

Two-storey structures are allowed to a limited extent and only with the approval of EXPO FUSION LLC An application for twostorey structures must be submitted after the stand has been approved. Together with the application, which must be submitted to EXPO FUSION LLC no later than 10 weeks before the start of installation, drawings of the stand must be submitted.

The supporting structures, ceilings of the first floor and the floor of the upper floor, in two-storey stands must be made made of non-flammable materials. All certificates must be ready to be presented at the time of stand acceptance.

2.3. STAND CONSTRUCTION BY OWN EFFORTS OR BY A CONTRACTING ORGANIZATION

In order to obtain a permit for stand construction at exhibitions held at Crocus Expo IEC, the exhibitor or the builder must agree in advance on the construction of the stand in accordance with the rules and requirements of the General Builder of BildExpo LLC.

2.4. CEILING FLOORS

Booths may have continuous ceiling ceilings made of non-flammable materials only in the booth area. If the area of the continuous ceiling floor is more than 30 square meters, such room must be equipped with a sprinkler system

2.5. ADVERTISING

Installation of billboards and posters is possible only within the boundaries of the stand. Promotional activities of any kind outside the stand is possible only after obtaining permission and paying the appropriate fee.

2.6. FIRE SAFETY

Cmoke and fire alarm systems

The owner of the exhibition complex prescribes the equipment of two-storey stands with cmoke and fire alarm systems. Installation of these systems is carried out by the divisions of the exhibition complex. The number of devices to be installed depends on the structural features of the stand

and the conclusion of the fire inspectorate. Payment shall be made simultaneously with the final payment or on site.

Balloons (aerostats)

The use of balloons filled with flammable gas in pavilions and open areas is prohibited.

The use of balloons filled with safe gas requires prior permission of the exhibition organizer.

Tanks for garbage, waste, residues

Do not keep containers with garbage, waste or residues of combustible materials on the stand. Garbage must be regularly taken to the designated places every evening after the end of the exhibition.

Spray guns, nitro lacquers

The use of spray guns and nitro lacquers is prohibited in all pavilions.

WORK WITH A GRINDING WHEEL IS FORBIDDEN, OPEN FLAMES, WELDING, FORGING, SOLDERING!

Cranes and forklift trucks

It is forbidden to operate own cranes and forklifts on the territory of the exhibition. Only the equipment of official forwarding companies may be used.

Packaging

It is forbidden to store containers of any kind (e.g. packaging and packing materials) on stands. Packagings must be removed by the freight forwarder to the designated storage areas.

Glass

Only laminated safety glass may be used. The edges must be treated or protected in such a way that there is no possibility of injury. Parts made entirely of glass must be marked at eye level.

Safety on the stand

Exhibition stands, including equipment and exhibits, as well as advertising structures must be installed in such a way that they do not pose a danger to the health and life of staff and visitors. Responsibility for static safety rests entirely with the exhibitor and, if necessary, he must present the relevant certificates.







Protective equipment

Machines and apparatus may only be operated with protective equipment. The management of the exhibition has the right to prohibit the operation of machines and apparatus if it creates a danger to people.

Pavilion floors

Carpeting must be laid in such a way as not to create a danger of injury. Only such adhesive tapes may be used to secure carpeting as will not leave residue after removal. All materials used must not leave residue after removal. Substances such as oil, grease, paint and similar substances must be removed from the floor immediately. It is not allowed to paint or glue the floor in the pavilions.

Security

The general security of the pavilions during the exhibition is provided by the organizer. During set-up and dicmantling, general security is also provided, which starts on the first day of set-up and ends on the last day of dicmantling. Security of the exhibitor's belongings shall be provided by the exhibitor himself. Additional security posts during the exhibition can only be provided by a security company on the basis of a separate order.

3. DURING THE EXHIBITION

3.1. Noise levels from equipment, audio-video demonstrations, etc.

GENERAL INFORMATION

In the interest of other exhibitors and visitors demonstrations of any kind should be limited as far as possible. Noise levels at the stand boundaries shall not exceed 75 dB (A).

3.2. Photography and filming

It is not allowed to photograph or film the exhibition exhibits in the pavilions and open areas. EXPO FUSION LLC has the right to use the pictures for its own and general publications.

4. PAYMENT, ADDITIONAL SERVICES

The Exhibitor may order additional services, which are located in the Technical guide (service). These services are chargeable. The cost is specified in the order forms for the respective services. The Exhibitor must order these services not later than the deadline specified in the form.
